A veteran best trusts a veteran exactly like him or herself. We make these connections by matching military service (branch, specialties, training, deployments, even injuries), post-service interests and geographic proximity. For example, a male, US Army Ranger communications specialist with deployments to Iraq and Afghanistan and an interest in IT might be connected to a Ranger communications veteran of Desert Storm who now owns a small IT business. The connections we facilitate overcome the sense of isolation that leads to potential problems.

4b (Code:) (Expenses \$ 34,650. including grants of \$) (Revenue \$ 35,772.) The Raider Project - Raider Project is a focused effort on the Marine Corps Special Operations (Raider) and combat infantryman. This unique brand of warrior is best served by one of their own, and in February 2014 The Raider Project began. By the end of 2014 Raider Project had helped over 150 Marine veterans with assistance ranging from drug addiction treatment to PTS therapy and employment.

4c (Code:) (Expenses \$ 30,334. including grants of \$) (Revenue \$ 124,666.) Run Ranger Run - Run Ranger Run is GallantFew's signature annual awareness and fund-raising event. Inspired by a Ranger veteran who ran, walked and biked 565 miles in a month, Run Ranger Run participants form teams of ten and commit to a combined total of 565 miles in the month of February. We raise awareness and funds through social media and the proceeds fund operations.
